**ORDER:**

In the reference 1<sup>st</sup> & 2<sup>nd</sup> read above, the Commissioner for Cooperation and Registrar of Cooperative Societies, A.P., Hyderabad has stated that Sri P.Krishna Mohan, Addl.Registrar has informed that prior to his joining in Cooperation Department he worked as a Lecturer in the Department of Cooperation and Applied Economics, Andhra University, Visakhapatnam from 7-8-1985 to 15-7-1987 which is a pensionable post Subsequently on selection as D.R by A.P.P.S.C, he resigned to his previous job and joined in Cooperation Department as Deputy Registrar on 16-07-1987. He has also stated that he will be falling shortage of the full qualifying service at the time of his retirement from Govt., Service i.e., 28-02-2014, and he has therefore, requested to count his previous service rendered in Andhra University for the purpose of pension as was ordered by the Govt., in respect of other Officers in similar cases.

**2.** The Commissioner for Cooperation and Registrar of Cooperative Societies, A.P., Hyderabad while enclosing the representation of the individual and requested the Govt., to take necessary action on the representation.

**3.** Government after careful examination of the matter, hereby count the past service rendered by Sri P.Krishna Mohan Addl.Registrar of Coop. Societies, as Lecturer in Andhra University, Visakhapatnam from 07-08-1985 to 15-07-1987 duly condoning the delay in exercising option as he is short of service for getting full pension, subject to remitting the pension contributions for the said period by the Andhra University or individual as per Rules in vogue.

**4.** The Commissioner for Cooperation and Registrar of Cooperative Societies, A.P., Hyderabad shall take necessary action accordingly.
