ORDER: -

The Secretary, APPSC, Hyderabad has furnished the unit list of the candidates provisionally selected for recruitment to the posts of Lecturers in Government Polytechnics with reference to the Notification No. 20/2011 in his letter 1st read above. The Government issued orders in the G.O.2nd read above approving the list of selected candidates and requesting the Commissioner of Technical Education, A.P., Hyderabad to issue the appointment orders to the selected candidates by APPSC, Hyderabad since he is the competent authority.

2. Accordingly, under Rule 10(a) of A.P. State and Subordinate Service Rules, 1996, Sri / Smt / Kum **As per Enclosed Annexure** has been temporarily appointed to the post of Lecturer in **As per Enclosed Annexure** in Government Polytechnics in the proceedings 3rd read above and he / she has been requested to attend the counseling for posting orders. The Scale of Pay of the post of Lecturer shall be Rs. 15,600-39,100/- with AGP of Rs. 5400/- [AICTE 2006 Pay Scales] with usual Allowances.

3. After considering the options submitted by him / her and based on counseling on 04.02.2013 Sri / Smt / Kum **As per Enclosed Annexure** is posted as Lecturer in **Physics** at Government Polytechnic, **As per Enclosed Annexure** in Zone **I to VI**.

4. The above candidates are directed to produce the following Original certificates to the Principal at the time of joining.

1. Certificates of Academic and Professional Qualifications.
2. Certificate of Physical Fitness from Civil Surgeon.
3. Date of Birth Certificate.

4. Study Certificate from the Head of Institution / Institutions for a period of (7) years ending with the academic year in which he appeared for the SSC Examination in support of his local candidature as defined in para 7 of the AP Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) order, 1975 (Presidential Order).
5. Community Certificate issued by the Competent Authority by the Candidates belonging to SC / ST / BC / Minority. (where ever applicable)
6. Order of relief from the present employer, if already employed and if not, self declaration to the effect that they are not employed at present. (where ever applicable)
7. Candidates selected under ST quota are required to furnish an undertaking in the specified proforma as per the Lr.Rc.No.43/97/TR-1/VC/7, Dated.10-02-1997 from the Commissioner of Tribal Welfare and the Community Certificate as verified by the Commissioner of Tribal Welfare. (where ever applicable)
8. Candidates belonging to BC Communities claiming reservations are required to furnish creamy layer Certificate as per G.O.MS.No.3, Backward Classes Welfare (C-2) Department, Dated.04-04-2008 of the Government of AP issued by the Competent Authority. (where ever applicable)
5. The Principal concerned are requested to personally verify all the above certificates produced by the candidate before accepting his / her joining reports and report lapses / deficiencies, if any, noticed to this office immediately.
6. As required under Para 11 (a) of AP State and Subordinate Services Rules, 1996 the candidates should join in the post within a period of (30) days from the date of receipt of this posting order, failing which the offer of appointment shall be treated as automatically cancelled and the name of the candidate shall be deemed to have been deleted from the list of approved candidates.
7. Sri / Smt / Kum **As per Enclosed Annexure** is governed by the Contributory Pension Scheme to Andhra Pradesh Government employees introduced vide G.O. 4th read above and General Provident Fund (Andhra Pradesh) Rules are not applicable to him/her as ordered in the G.O. 5th read above.
8. No T.A will be admissible for them to join the post.
9. It is hereby certified that the appointments of the candidates ordered in para (2) above, or in accordance with section (4) of the AP (Regulation of Appointments to Public Services and rationalization of staff pattern and Pay Structure) Act, 1994.
